

NOTICE OF ELECTION

TO THE DULY QUALIFIED RESIDENT VOTERS OF HARRIS COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NO. 36:

Notice is hereby given that a bond election (the "Election") will be held for and within Harris County Water Control and Improvement District No. 36 (the "District"), pursuant to an Order of the Board of Directors (the "Board") of said District adopted on August 12, 2025. Said Order is on file in the District's Designated Agent's office located at 2929 Allen Parkway, Suite 3150, Houston, Texas 77019-7120, where any interested person may refer to it for all purposes.

It is estimated by the Board that the probable cost of design, construction, purchase, and acquisition of improvements, including but not limited engineering fees and construction contingencies, is estimated to be \$57,595,116. The cost of non-construction items, including but not limited to capitalized interest and operating expense, financial advisor's fees, legal fees, bond discount, printing and issuing bonds and non-construction contingencies, is estimated by to be \$27,204,884.

Election Day Polling Locations and Hours

The Election will be held between 7:00 a.m. and 7:00 p.m. on Tuesday, November 4, 2025, at all Harris County countywide polling places described on the attached Exhibit "A," which are all public places, and shall conform to all the requirements of Chapter 49, Texas Water Code, as amended, and all of the requirements of the Texas Election Code, as amended, so far as applicable.

Early Voting Polling Locations and Hours

Early voting by personal appearance shall be conducted at the polling locations, dates and times identified on Exhibit "B," attached hereto or as otherwise set by Harris County Elections Administrator during the times set by Harris County in accordance with the Election Code. Early Voting shall commence on Monday, October 20, 2025 and continue through Friday, October 31, 2025, as provided by the provisions of the Texas Election Code.

Only duly qualified resident electors of the District may vote at the Election.

The bond propositions to be voted on in the Election are as follows:

PROPOSITION A

THIS IS A TAX INCREASE. SHALL THE BOARD OF DIRECTORS (THE "BOARD") OF HARRIS COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NO. 36 (THE "DISTRICT") BE AUTHORIZED TO ISSUE THE BONDS OF SAID DISTRICT IN ONE OR MORE ISSUES OR SERIES IN THE MAXIMUM ORIGINAL PRINCIPAL AMOUNT OF EIGHTY-FOUR MILLION, EIGHT HUNDRED THOUSAND AND 00/100 DOLLARS (\$84,800,000). MATURING SERIALLY OR OTHERWISE OVER A PERIOD NOT TO EXCEED 40 YEARS FROM THEIR DATE OR DATES, AND TO BE ISSUED AND SOLD AT ANY PRICE OR PRICES AND TO BEAR INTEREST AT ANY RATE OR RATES AS SHALL BE DETERMINED WITHIN THE DISCRETION OF THE BOARD OF THE DISTRICT AT THE TIME OF ISSUANCE AS AUTHORIZED BY LAW AS NOW ENACTED OR HEREAFTER AMENDED, FOR THE PURPOSES OF FINANCING THE CONSTRUCTION, REPAIR AND REPLACEMENT OF THE DISTRICT'S WATERWORKS SYSTEM AND SANITARY SEWER SYSTEM, AND TO PROVIDE FOR THE PAYMENT OF PRINCIPAL OF AND INTEREST ON SUCH BONDS BY THE LEVY AND COLLECTION OF A SUFFICIENT TAX UPON ALL TAXABLE PROPERTY WITHIN SAID DISTRICT, ALL AS AUTHORIZED BY THE CONSTITUTION AND LAWS OF THE STATE OF TEXAS?

PROPOSITION B

THIS IS A TAX INCREASE. SHALL THE BOARD OF DIRECTORS OF HARRIS COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NO. 36 (THE "DISTRICT") BE AUTHORIZED TO ISSUE THE BONDS OF THE DISTRICT, MATURING SERIALLY OR OTHERWISE OVER A PERIOD NOT TO EXCEED 40 YEARS FROM THEIR DATE OR DATES, AND TO BE ISSUED AND SOLD AT ANY PRICE OR PRICES AND TO BEAR INTEREST AT ANY RATE OR RATES AS SHALL BE DETERMINED WITHIN THE DISCRETION OF THE BOARD OF THE DISTRICT AT THE TIME OF ISSUANCE AS AUTHORIZED BYLAW AS NOW ENACTED OR HEREAFTER AMENDED, FOR THE PURPOSES OF REFUNDING ANY BONDS OR OTHER EVIDENCES OF INDEBTEDNESS OF THE DISTRICT ISSUED FOR RECREATIONAL FACILITIES, WHICH MAY BE OUTSTANDING FROM TIME TO TIME IN THE MAXIMUM AMOUNT NOT TO EXCEED EIGHTY-FOUR MILLION, EIGHT HUNDRED THOUSAND AND 00/100 DOLLARS (\$84,800,000), AND TO PROVIDE FOR THE PAYMENT OF PRINCIPAL OF AND INTEREST ON SUCH BONDS BY THE LEVY AND COLLECTION OF A SUFFICIENT AD VALOREM TAX AUTHORIZED BY CHAPTERS 49 AND 51 OF THE TEXAS WATER CODE, UPON ALL TAXABLE PROPERTY WITHIN THE DISTRICT, ALL AS AUTHORIZED BY THE CONSTITUTION AND LAWS OF THE STATE OF TEXAS?

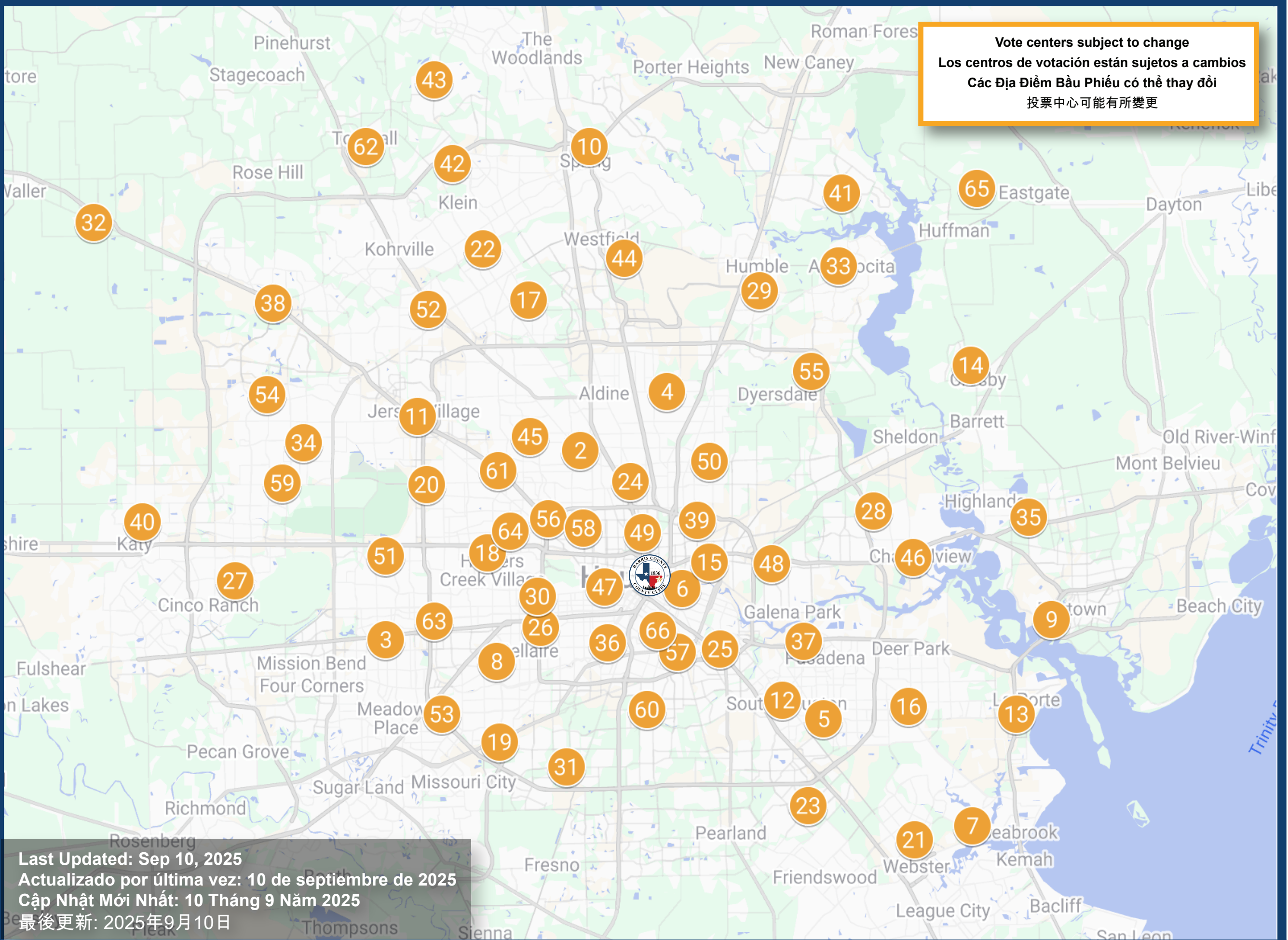

(1) Assumes an interest rate of 5.50% on the Proposed Bonds and issuance in accordance with the assumed amortization schedule described below. The estimated interest and amortization schedule

are based upon current assumptions and projections of interest rates, property development, assessed valuations and tax collection rates. To the extent that such assumptions and projects are not realized, the actual interest on the bonds may vary substantially from the estimated interest presented herein. The estimated interest provided herein shall not be considered part of the bond propositions to be submitted to the voters and shall not be considered as a limitation on the District's authority to levy, assess and collect an unlimited tax as to rate or amount pursuant to the Texas Constitution and laws.

- (2) Aggregate of all outstanding obligations of the District secured by and payable from ad valorem taxes as of August 11, 2025.

Estimated Annual Increase in Taxes:

The estimated maximum annual increase in the amount of taxes that would be imposed on a residence homestead in the political subdivision with an appraised value of \$100,000 to repay the debt obligations to be authorized under Proposition A, if approved, based upon assumptions made by the governing body of the District, is \$309.

Major Assumptions:

The foregoing information is based upon the following assumptions made by the District's Board of Directors: 1) issuance of the proposed bonds with an amortization schedule that, when combined with the District's current debt service requirements, will produce relatively consistent combined annual debt service requirements over the life of the proposed bonds; 2) assumed growth in the District's assessed valuation of 3.0% per year until 2061; and 3) an assumed interest rate on the proposed bonds of 5.50%.

The information provided in this Document is to comply with Section 1251.052, Texas Government Code, which requires a voter information document for each proposition to be submitted to the voters. Reference is made to the Voter Information Documents for the District's other propositions, if any, which follow or precede this document, for additional information pertaining to other potential new debt of the District.
